## About

Under the ISPS Code, there is a minimum security certification requirement for anyone working onboard or frequenting a vessel often.

The fully online, ISPS Code compliant, UK DfT Maritime & Coastguard Agency [STCW ISPS] Proficiency in Security Awareness [PSA] Course, also referred to a Vessel Security Awareness [VSA] is the mandatory, minimum training requirement under STCW ISPS for members of a Ship's Crew or Staff who do not have assigned designated security duties on board ship.

This course has been specifically tailored for Commercial Cargo Vessels, Offshore Mobile Platforms and Ferry Crew & Staff.
